The last date of receipt of hard copy of the application is 2/08/2019, Wednesday, before close of office hours.

- b) Self-attested copies of all certificates and testimonials in proof of age/ educational qualifications/ caste / experience etc. should be attached along with the hard copy of the application.
- c) Those candidates who are employed in Govt. /Semi Govt. /Autonomous Bodies etc. should send their hard copy of applications through proper channel. However, they may send an advance copy of their application along with other attested certificates and testimonials to the above address so as to reach on or before the schedule date.
- d) The date and venue of the test/interview for short listed candidates shall be informed later through email.
- e) The posts are to be filled up on long term contract basis initially for a period of 3 years.
- f) Any form of canvassing will lead to disqualification of candidature
- g) The Short listed candidates for the above mentioned post will have to appear for the Screening process which may include written test and skill test. No TA/DA shall be paid to any of the candidates for attending the screening process.
